#### The <u>Walnut Park Elementary School</u> will:

Walnut Park will use the state courses of study to guide our curriculum and hire only qualified teachers. Our teachers will be monitored by the administrator in the building and by the Central Office administration. We will use assessments to guide our instruction. Instruction will be guided by using the strategies presented in our Reading Initiative, Really Great Reading, OG, SPIRE, and AMSTI training so that we can accurately assess our student's knowledge levels. Along with those strategies, technology will be added to our instruction to ensure our students not only have a high quality education, but also receive instruction using the latest technology available. We will treat all children in a fair manner.

1. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held:

The school will hold conferences with parents during their planning times during the first nine week period of school. Parent conferences will also be held when a parent requests a conference. We try to give the parent /teacher a 24 hour notice.

1. **Provide parents with frequent reports on their children's progress.** Specifically, the school will provide reports as follows:

The school will provide status reports and grades in Powerschool and in the form of graded work for parent signatures weekly. The school will send progress reports home every 4 and a half weeks and send home report cards every nine weeks during the school year. The school will also send various forms of communication with the use of Facebook (school webpage), email, and/or text frequently to promote more parental involvement.

1. **Provide parents reasonable access to staff.** Specifically, staff will be available for consultation with parents as follows:

The school staff will be available each day 15 minutes before the students arrive and 15 minutes after school when the school day ends. Parents will be allowed to come in for special reading times (approved by the principal) (Special Days) that occur during the year. Teachers will also have a planning time each day during their PE time that can be used for parent conferences. We would like for our parents to participate in Open House, parent nights (literacy reading nights), and Title I meetings (Annual meetings) which may be virtual. Parent conferences will be held when a parent requests a conference. We try to give the teacher/parent a 24 hour notice.

1. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:

Volunteer opportunities are available with permission from Administration/Central Office as needed. If observation is needed it will be arranged through the administrative office at the school and with the central office. Parents are encouraged to participate for special occasions that the school hosts. This still may be limited due to the pandemic. Examples of these opportunities are as follows: Open House, Meet and Greet, Supply drop off, Book Fairs, Grandparents Day, PTO Sing-A-Long, Spring Fling, and Trunk or Treat.

1. Ensure regular two-way, meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand.

Communication between the parents and the staff will be conducted through student folders and planners used all year long. Communication will be delivered in a language that the parent can understand. Parent meetings and conferences will be held all year and parents who need an interpreter will be provided one for the meetings.
